- **U13/U14 Boys - Spring Season Only** - Total fees \$350.00 + Uniform (\$87 last season...may adjust slightly) = \$427

Parent Responsibilities (initial each statement to confirm that you have read it):

____ All payments are expected to be paid on time to ABYSA. Payments may be paid online by credit or debit card, mailed to PO Box 895, Asheville, NC 28802 or brought by the office - we have a drop box for after hours.

____ Any payment in excess of 30 days past due may result in the surrender of a player's member card (player pass). Players will not be allowed to practice or play until the card is reinstated.

____ Your payment schedule must be met unless the Director of Business Operations has approved a written request for late payment in advance of the due date. We are willing to work with you but you need to communicate with us. *Statements will not be sent out in advance of the due date.*

____ Limited Financial Aid is available for those families truly in need. Applications must be received in the ABYSA/HFC office by July 15th for Fall Season applications and January 15th for Spring Season applications. Keep in mind that tax statements, pay receipt copies, and other documentation will be required with your application for financial aid. Applications cannot be considered until all documentation is received.

____ If there is more than one parent who is financially responsible for player's fees both parents MUST sign or each must send in a separate form (as in divorce situations), otherwise the parent(s) signing below will have full financial responsibility for player's fees.

____ I agree that by signing this *Player Commitment & Financial Contract* the player is committed to HFC Challenge for the NCYSA seasonal year beginning September 1, 2017 and ending August 31, 2018. By signing this form I understand that I am not only binding the player to the club, but I am also making a commitment to meet my financial obligations to the club for the seasonal year and will forfeit any fees paid if player resigns from program within the 30 days prior to the beginning of training except in cases of injury, sickness or if our family relocates out of the area.
